We would like to welcome you to the St. Jude Summer Care Program and thank you for entrusting your child(ren) to our care. We are a Christ-centered program striving to maintain a positive atmosphere where the children can learn to take responsibility for their actions as they make choices to do homework, play, and use their imaginations. We look forward to working with your child(ren) during this summer.

### Policies

**Eligibility:** Children who are rising Pre-K through 5th grade who will be attending St. Jude School for the 2026/2027 school year. Children must have a summer registration form completed before attending summer care. Pre K3 students must turn 3 and be potty trained before they begin attending.

**Calendar/Times:** June 1st- 30th and July 1st- 24<sup>th</sup>, Monday- Friday 7:30 am-6:00 PM with full and half day options.

**Goals:** To create a caring, loving, enjoyable and safe environment for each of your children. To give you as parents and guardians the confidence that your child is being well cared for in an atmosphere that promotes the use of time for learning, reading, and self-development through play and interaction with others.

**Discipline:** The children are expected to use proper manners and show respect, common courtesy, and consideration for their classmates and staff. The school policies are our guidelines. Physical and/or verbal abuse will NOT be tolerated. In Summer Care, we have a 3 strikes policy. After the third strike your child will be unable to participate in our program.

**Gear:** Children need to have the appropriate outerwear for outdoor play. Water bottles are a must. Please send sunblock labeled with your child's name. Snacks will be provided, but children may bring an extra snack. Please send a lunch daily, no lunch options are provided.

**Pick up:** All children MUST be signed out and will not be released to anyone not listed on the application unless notified in writing or by phone.

**Communication:** Watch FACTS for posting to accounts and to communicate via email. Please make sure the information on FACTS is current. This is our only form of communication.
